DIRECTIONS TO SHOW HEADQUARTERS

FROM THE NORTH: TAKE I-65 SOUTH TO EXIT 117 (SHEPHERDSVILLE)  
AT THE RAMP, MAKE A RIGHT ONTO HWY 44 WEST. AT THE FIRST  
LIGHT, MAKE A LEFT ONTO PAROQUET SPRINGS DRIVE. THE  
CONFERENCE CENTER WILL BE ON THE LEFT.

FROM THE SOUTH: TAKE I-65 NORTH TO EXIT 117 (SHEPHERDSVILLE)  
AT THE RAMP, MAKE A LEFT ONTO HWY 44 WEST. AT THE SECOND  
LIGHT, MAKE A LEFT ONTO PAROQUET SPRINGS DR. THE  
CONFERENCE CENTER WILL BE ON THE LEFT.

NOTICE

In accordance with the AKC Obedience Regulations , entries in this Tracking Test shall be accepted up until the official closing date even though the advertised limit has been reached. The drawing for this test shall take place on Wednesday, April 16, 2014 at the home of the Test Secretary, 4006 Willowview Blvd., Louisville, KY at 7:00PM and the public is invited. At that time it will be determined which of the entries will participate in the event. The drawing will be at random among all entries but preference will be given to dogs which have not earned a VST title. When the limit has been drawn, all remaining entries shall be drawn in the same manner and assigned a position on the alternate list.

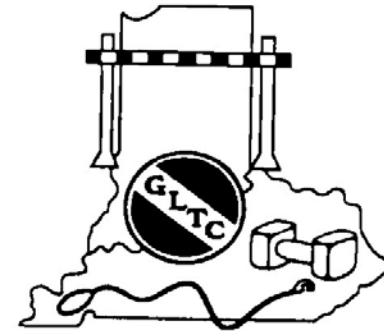
ALL ENTRIES WILL BE NOTIFIED BY PHONE OR EMAIL ASAP

Entry fees will not be refunded for any reason other than for bitches who come into season after the closing date, alternates who do not run, and entrants replaced by an alternate at the test. Bitches in season entries will be returned, less \$2.00, by turning in a statement from a veterinarian before the drawing of tracks on the test day. Entry fees will be refunded within seven (7) days following the test. In the event an accepted entry cancels prior to the test date, the test secretary shall contact alternates according to their placement on the alternate list and upon notification, said alternate shall have the option of accepting or refusing the opportunity to participate in the test. In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the judges to assign dogs to the tracks by the drawing of lots.
